CQC	<ul> <li>Christopher Jarvis, CQC inspector and Amanda Reynolds, CQC regional manager attended the meeting to update the committee about how they will be moving away from their transitional monitoring approach and introducing new monthly reviews which will be based on data and information on the practice.</li> <li>Chris Jarvis and Amanda Reynolds will be speaking at an event for practices on the 6<sup>th</sup> July to provide more information about these changes. LMC Constitution	<ul> <li>Committee discussed whether the LMC constitution needs to be amended to align more with PCNs; currently representation is based on the old CCG localities.</li> <li>The committee agreed that representation should be in line with the PCN areas but that the committee should remain diverse and still be representative of all GPs.</li> </ul>
2WW referral pathway for non- specific symptoms	• Committee reviewed a proposed new referral pathway for suspected cancer patients who are displaying non-specific symptoms and do not meet criteria for other 2WW referrals.
Stock Shortages Protocol	<ul> <li>Committee reviewed a new protocol developed together by Pharmacy Lincolnshire and the LLMC to improve the process for when medications are out of stock or having supply issues.</li> <li>Committee approved this protocol and agreed to review again once there are use cases.</li> </ul>
Dermatology Pathway	<ul> <li>Drs Sharrock and Dodington-Boyes of the LLMC have been working with ULHT dermatology department to improve referral pathways. These changes are aimed at improving access and speed of response from dermatology, and to better use technology to reduce patient travel. Committee reviewed the proposed pathways and provided feedback which will be forwarded to the ULHT dermatology evolution group.</li> </ul>
