General Practice Alert State to go live to all Lincolnshire Practices.

After a successful pilot, GPAS is now ready to go live with all Lincolnshire Practices on **Tuesday 3rd May 2022.**

An email has been sent to all Practice managers this week, which includes a Lincs LMC guide to GPAS.

The submission takes under 5 minutes to complete once a week and the anonymised data can be used to provide reports detailing the capacity and pressures experienced at a PCN, locality and countywide level.

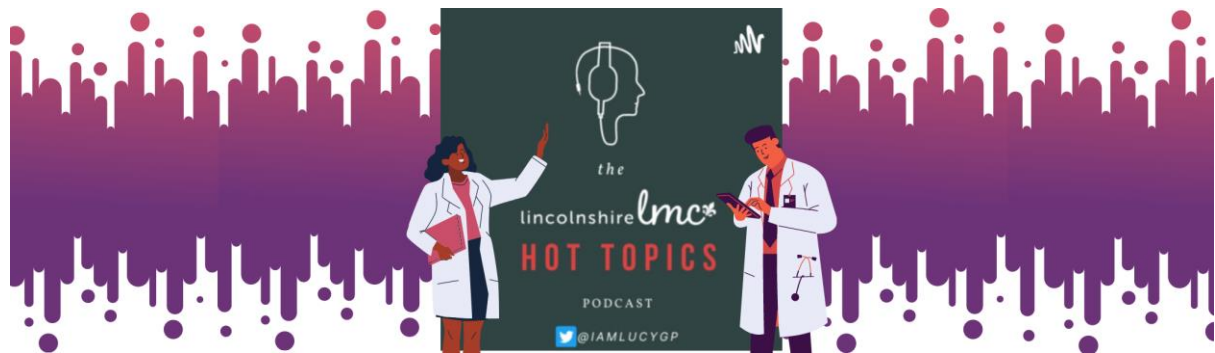
