## **Practice Updates**

#### Survey on contracting arrangements for GP LARC services - www.lincslmc.co.uk/news

Lincolnshire County Council (LCC) is reviewing future commissioning arrangements for sexual health services, including Integrated Sexual Health (ISH) services and GP Long-Acting Reversible Contraception (LARC) services from April 2024.

Maintaining and improving access to LARC is a local and national priority. As such, we are seeking views from GPs (both incumbent deliverers and interested practices) on two possible future contracting arrangements to understand the likely impact on delivery of LARC services. Engagement with the wider market and other local authorities show both approaches to be viable.

The two possible contracting arrangements are:

- The current model whereby GPs contract directly with LCC
- An integrated model whereby ISH service (third-party) provider is responsible for all LARC service delivery and would form its own contracts with GPs to ensure broad community access to LARC services.

Please note, depending on the outcome of the ISH service re-procurement, the future ISH provider in Lincolnshire may be an NHS organisation or a private provider.
