Update to existing LMC guidance - [Staff training for people with a learning disability or autism](#)

Autism and Learning Disability training.

The 'Oliver McGowan Mandatory Training on Learning Disability and Autism' is the title of HEE and NHSE's preferred training, but it is **NOT** mandatory that this training is completed. It is unfortunate that the title of the training contains the word mandatory as this appears to have increased confusion. There was also concern that CQC suggested that this training was mandatory.

CQC has now amended its guidance, which now clarifies that there is no specific training that is mandatory. CQC states that training 'provided to staff is **APPROPRIATE** and provides staff with knowledge about how to interact and support people with a learning disability'.

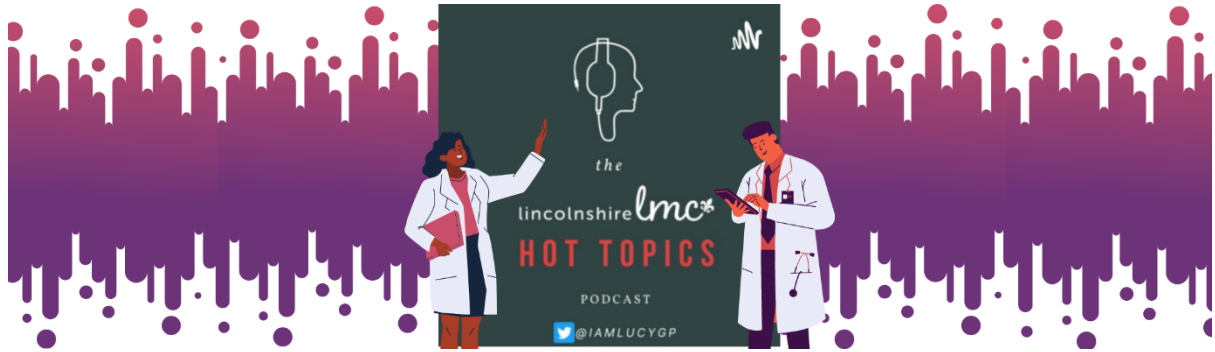
