The form can be accessed and completed using the link found in your GPAS open email

Practice Update: **General Practice Alert State**

Every week we send a '**GPAS is open**' email to your specified GPAS delegate (this will be the practice manager by default). Within this email contains the link to the GPAS survey which is comprised of 6 easy questions that will only take a couple of minutes to complete. The data you provide is completely anonymous and support requests are kept strictly confidential within the LMC.

Why should I fill in the GPAS survey?

It is crucial to demonstrate the huge demand practices face that we know exists so that we can use it to evidence the need for there to be system response to support General Practice. We are currently receiving around a **40% return rate**, thank you to those practices who continuously submit their data. We need data from as many Practices as possible and it needs to be maintained into the future to provide comparisons for future capacity planning and an effective response to continual pressures.

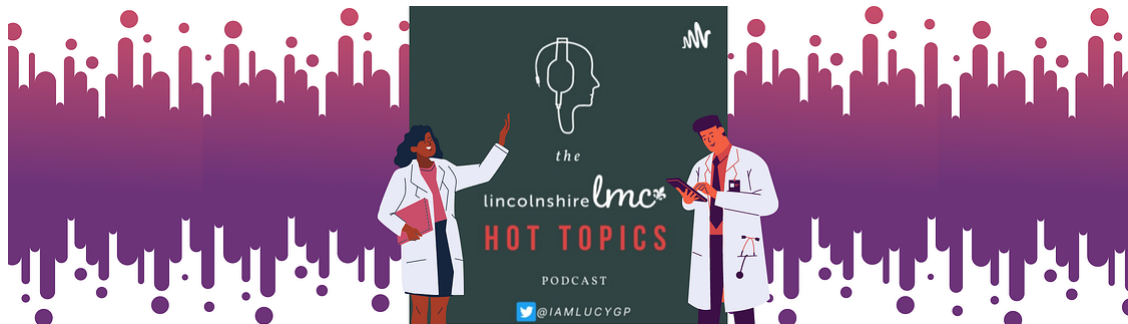
