General Practice Alert State is OPEN every Tuesday for your practices' input

The form can be accessed and completed using the link found in your GPAS open email

Every week we send a 'GPAS is open' email to your specified GPAS delegate.

Why should practices complete the GPAS survey?

It is crucial to demonstrate the huge demand practices face that we know exists so that we can use it to evidence the need for there to be system response to support General Practice. We are currently receiving around a 40% return rate. We require data from as many practices as possible, consistently, to provide comparisons for future planning. **This survey takes less than five minutes to complete and could have a big impact on the response to continual pressures.**
