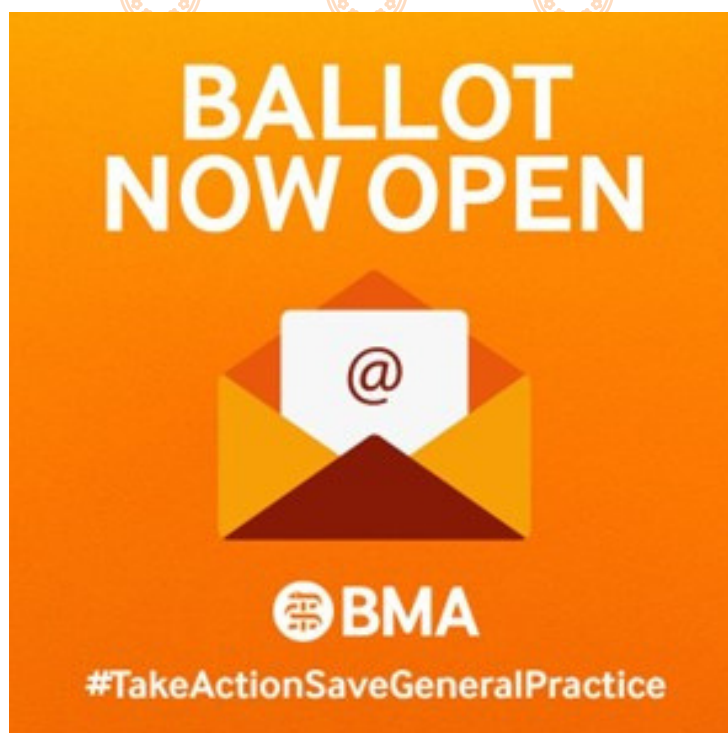

# BMA AND LMC VIEW – NATIONAL PILOT ON NEW WAYS OF WORKING IN GENERAL PRACTICE

This article has been written to advise you on the BMA and LMC View on the national Pilot on New Ways of Working in General Practice. As you may be aware Lincolnshire is one of seven pilot areas that have been selected in England. This was likely to be the case following Clare Fuller's earlier visit to the county.

The BMA and Lincolnshire LMC must strongly recommend to member practices that they decline to take part.

This is a practice led project, all practices in a PCN must agree to sign up. Explicit agreement must be made by the GP contract holders in each practice within a PCN.

Consider the following:

- This is a large data gathering exercise by NHS England.
  - Loss of your practice's intellectual property.
    - Do you want to give all your business data and intelligence away to NHS England?
  - There is also inadequate funding to remunerate for disruption caused by the gathering of data.
- Absence of any focus on improved patient outcomes.
- Lack of detail provided about how the extra capacity will benefit core General Practice.
  - More staff to supervise and take responsibility for.
- Lack of clarity about the continuation of funding after March 2027.
- The potential for this pilot to limit your freedom to engage in collective action in defence of General Practice alongside your colleagues.
- This pilot may well be halted by a new incoming Government.

Remember this is foremost a data gathering exercise and all practices in a PCN must agree to take part.

## TIER RATES

NHS Pension Scheme members are reminded that contribution tier rates changed from 1 April 2024.

The table below shows the contribution rates for each salary range that are applicable in 2024/25.

Pensionable salary range	Contribution rates from 1 April 2024 <i>(based on actual annual pensionable pay)</i>
Up to £13,259	5.2%
£13,260 to £26,831	6.5%
£26,832 to £32,691	8.3%
£32,692 to £49,078	9.8%
£49,079 to £62,924	10.7%
£62,925 and above	 12.5%

# UPDATE ON CERVICAL SCREENING MANAGEMENT SYSTEM (CSMS) GO-LIVE



NHS England is pleased to confirm that the [CSMS](#) is now live.

It replaces the previous Open Exeter call/recall IT system and is now accessed via an NHS smartcard. The Open Exeter system is no longer accessible for the purposes of delivering NHS Cervical Screening Programme services.

For any technical support with using or accessing [CSMS](#) please visit the [CSAS website](#).

All GP Practices are asked on Monday 24 June 2024 to log on and review the notification section:

- to check that the contact email details for Prior Notification Lists (PNLs) are correct (click on 'manage email' within notifications section). If incorrect, please amend on [CSMS](#), ensuring it's a generic email contact address.
- to check the details of any patients due to be invited and action accordingly.

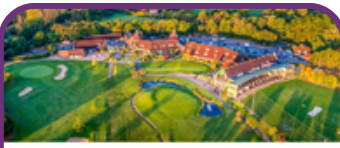
