# Government Announcement Regarding NHS England and ICBs

It is likely that you are all aware of recent announcement made by the Prime Minister that there will be "major reforms to NHS England to empower NHS staff and put patients first".

Additionally it was announced that ICBs, including Lincolnshire, will have to reduce operating costs by 50%.

Lincolnshire LMC is currently awaiting further information to see how this will affect Lincolnshire General Practice and we will keep members updated as new information comes to light.

## **Summary of Major Changes to the GP Contract for 2025/26**

The high-level detail of the 25/26 GMS contract were released last week and below is a summary of them.

GPC England voted to accept this contract offer dependent on the written commitment of Wes Streeting to develop a new substantive contract for general practice which is currently awaited.

The new contract is a step in the right direction but there are potential challenges the new requirements may bring.

The headline funding uplift of £889m includes cost pressures for increased NI contributions, NMW increases and inflationary pressures. Once these practice costs and the recycling of QOF money into core is taken into account, the £889m uplift is much smaller and does not nearly provide the significant financial uplift general practice requires.

A&G utilisation will be capped and funded at £20 per episode of care. While this is additional funding into practices, is approximately 50% less than it would cost a practice to engage with it. How this cap and the process will work remains to be seen.

Online access being available throughout core hours for patients to send enquiries

and book appointments could be a further demand on practices at a time of great pressure.

There will be further national discussion and updates. For now, we reflect on some positives and thank the hard work of GPCE colleagues but must remain focussed that there is much more our great profession needs to sustain it as the bedrock of the NHS.
